**Notice of Nomination Meetings
For the California Table Grape Commission**

To The California Table Grape Producer Addressed:

Notice is hereby given of nomination meetings to be held in the six major grape producing districts within the state. The purpose of these meetings is for table grape producers to make nominations for six members of the Table Grape Commission whose terms of office will begin April 1, 2014.

Subsequent to the nomination meetings in each of the districts, a mail ballot election will be held in order to determine the persons from each district who will be recommended to the Department of Food and Agriculture for appointment to the Commission. Please note that the California Table Grape Commission Law encourages forwarding to the Department the names of two nominees per district.

To qualify as a member of the Commission, a person must be a citizen and resident of California over 25 years of age. In addition, the individual must be a producer, partner, or an employee of a producer who is at the time of the election, and has been for at least five years previously, actively engaged in growing table grapes within California. Further, not more than two Commission members can be employed by, or connected with in a proprietary capacity, the same corporation, business firm, partnership, association or business organization. Finally, in any of the six districts, no more than one member may be so employed or associated.

The term of office of the six Commission members to be selected this year shall be three years from April 1, 2014 through March 31, 2017

A schedule of the nomination meetings is provided on the reverse side of this notice. It indicates the location, date, and time of the nomination meeting in each district.

You are invited to attend and participate in the nomination meetings. Fresh grape producers will be able to make nominations in all districts in which they produce grapes. Therefore, a producer may attend all of the meetings for districts in which he or she has vineyards.
