The California Department of Food and Agriculture is currently soliciting nominations from industry organizations and individual fishermen for persons interested in being appointed to an available position on the California Salmon Council. For your reference, a list of the current members and alternates of the California Salmon Council is enclosed. Members and alternate members with terms expiring on March 31, 2013 and all vacant positions are shown in **bold type**. This year, nominations are being sought for the three Commercial Salmon Vessel Operator (Vessel Operator) member positions, two Vessel Operator alternate member positions, two Commercial Salmon Receiver (Receiver) member positions, and two Receiver alternate member positions.

Nominations for any of the available Vessel Operator positions mentioned above may be submitted by individual commercial salmon fishermen or organizations representing commercial salmon fishermen. Likewise, nominations for any of the available Receiver positions mentioned above may be submitted by individual receivers or organizations representing receivers. On the enclosed nomination form, please set forth (1) the name and address of the nominee, (2) whether the nominee is being nominated as a member or alternate member, (3) a list of qualifications and supporters for the nominee, if any, (4) check box to verify that this nominee is willing to serve if appointed and (5) the name and address of the nominating individual, marketing association or organization (if applicable) and your signature and title.

For your convenience, we have enclosed a blank nomination form and a self-addressed return envelope.
